# **ENROLLMENT**

#### **TUITION COURSES**

For a student to be enrolled for tuition courses, the enrollment form must be completed and accompanied with an identification card/document, along with full fees or a minimum deposit of 300,000 ugx per course. #### **REVISION COURSES**

For a student to be enrolled for revision, the completed enrollment form must be accompanied by full fees. There are no part payment or installment schemes for revision courses. An enrollment form which includes a revision course will not be accepted without full payment.

# **PAYMENT OF FEES:**

Once enrolled, students are obliged to pay the balance of any outstanding fees not later than 1 months of study.
